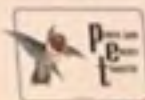

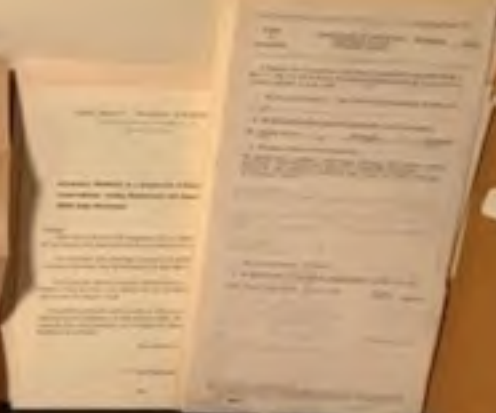

December 10, 1959, the Apollo Foundation was established as a none-profit research foundation. The participating members and founders are: Otis T. Carr, Warren W. Philbrick, Norman E. Colton and Thor Thoroddsson.

Some rules: No payments are to be made from the foundation unless it is authorized by the foundation by unanimous decision. Further as a policy there will be no outlay of funds unless it has to do with gainful participation in the projects already planned. Two (out of four) signatures are required on all checks.

Exclusive license is given to the foundation from the OTC Enterprises on the OTC-X12 Gravity motor.

Detailed specifications regarding these two projects or prototypes will be part of identifying these units. The terms are to be 6% on gross production sales, duration ten@years. The funds needed to carry on the work are presently loaned to the Foundation by Warren W. Philbrick. Activities and participation based on the minimum survival needs - at present.

FINAL JUDGMENT

PERMANENT INJUNCTION

It appearing to the satisfaction of the Court, from the plaintiff's verified complaint, the affidavits and transcript of testimony filed herein in support of plaintiff's motion for a temporary restraining order and motion for preliminary injunction, and the written stipulation of the defendants consenting to the entry of a final judgment forthwith, permanently enjoining them, and each of them, as demanded in the complaint, that the plaintiff is entitled to a final judgment permanently enjoining the defendants OTC Enterprises, Inc., Otis T. Carr, Lari Kendrick and Charles O. Rhoades from offering for sale, selling and delivering after sale securities, in violation of Sections 5(a)(1), 5(a)(2) and 5(c) of the Securities Act of 1933, as amended [15 U.S.C. 77e(a)(1)],

77e(a)(2) and 77e(c)]; and it further appearing that unless enjoined said defendants will sell securities in violation of the aforesaid sections of the said Act;

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED

on this the 5th day of June, 1959, that the defendants OTC Enterprises, Inc., Otis T. Carr, Lari Kendrick and Charles O. Rhoades, their officers, agents, employees, attorneys, successors and assigns, be and they are hereby permanently enjoined from

(a) making use of any means or instruments of transportation or communication in interstate commerce or of the mails to sell securities, namely options and rights to purchase and deposits receipts for shares of capital stock in OTC Enterprises, Inc. and shares of capital stock in OTC Enterprises, Inc., or any other securities, through the use or medium of any prospectus or otherwise, and

(b) carrying such securities, or causing them to be carried, through the mails or in interstate commerce by any means or instruments of transportation for the purpose of sale or delivery after sale;

unless and until a registration statement is in effect with the Securities and Exchange Commission as to such securities;

(c) making use of any means or instruments of trans-
portation or communication in interstate com-
merce or of the mails to offer to sell any such

prospectus or otherwise, unless and until a
registration statement has been filed with the
Securities and Exchange Commission as to such
securities, or while a registration statement
filed with the Securities and Exchange Commis-
sion as to such securities is the subject of
a refusal order or stop order of the Securities
and Exchange Commission or [prior to the effec-
tive date of a registration statement] any pub-
lic proceedings or examination under Section 8
of the Securities Act of 1933, as amended;

provided that the foregoing shall not apply to any secu-
rity or transaction which is exempt from the provisions
of Section 5 of the Securities Act of 1933, as amended.

IT IS FURTHER ORDERED that a copy of this final
judgment be served upon each of these defendants and also
upon the following officers, directors and employees of
the defendant OTC Enterprises, Inc.: Norman E. Colton,
Wayne S. Aho and Hildegard W. Shea.

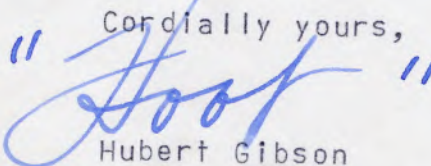
Your letter of June 20, 1961, was a most welcome relief from a terrific strain I had been under. I had made all sorts of attempts to get in touch with you concerning your case here, such as: calling your half-brother in Los Angeles, your brother in Baltimore, Norman Colton, Hidegarde Shea, Alex Andreotta, and Bob Young. All to no avail.

The 90 day stay of execution that the court granted you on March 17, 1961, expired on June 16, 1961. Your failure to appear at that time cost me more than considerable embarrassment, both with the County Attorney and with our good friend Judge Mills, who had so graciously granted us the 90 day stay of execution. After prostrating myself and appealing to the mercy of the court with every bit of sincerity and eloquence that I possess, the court reluctantly extended the time for execution of sentence for another 30 days.

This means absolutely, positively, and unfailingly you must be here in my office at 9 o'clock on the morning of Monday, June 17, 1961. Your failure to appear at that time will destroy all the good work that I have done in your behalf and could quite possibly result in a Federal charge of "Unlawful Flight To Avoid Prosecution" being lodged against you.

I can assure you that you will not be held in the Oklahoma County jail. Your appearance here is a legal technicality that is necessary as evidence of our good faith in order for me to secure additional time within which we will pay the fine and court costs.

Please let me hear from you at once.

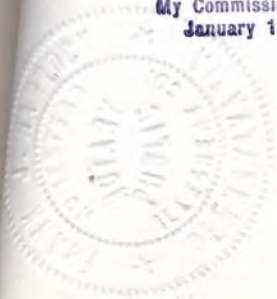

Dear Jerry,

I am trying to make this letter as complete as possible and avoid misunderstanding, so bear with me as I ramble along.

The emotional flare-up that plagued me has disappeared and I am approaching the future with calmness and a sensible understanding of the problems involved. I believe that my feelings can be understood by you when you probably join in knowing with me that through my inventions I own title to a power system better than any before manifested upon this planet in this cycle of history. All the oil wells, all the coal mines and all the dammed up rivers do not compare with the potential that we have discovered and are trying to make manifest. The disclosures I made to you on your last visit here, July 19, 1965, have all been validated by testing on the machine in its present stage. The fact that we can gain energy by lifting weight due to the novelty of the floating fulcrum is a total and conclusive manifestation of free power-gain up to the infinite when properly engineered.

I am enclosing witnessed xerox sketches of the various data that I revealed to you on your visit here and please proceed with the patent applications as we agreed upon. In reference to the patents, please send me a letter acknowledging that the two Canadian patents are in the process of filing and whatever is needed by me to document same. I will now get back to the machine and problems involved in our producing an electrical power-gain and how I plan to meet them.

The machine with the necessary weight and floating fulcrum now operates at the required rpm using approximately 75 watts which in itself is a tremendous achievement keeping several thousand pounds dynamically in motion at less than is required to burn a 100 watt bulb. When we began to add sufficient weight to the machine to gain the electrical power output

required, we ran into a setback. The one inch shaft on the floating fulcrum bent and set up several binding parts that immobilized the effectiveness of the machine. We could not afford the necessary time to remachine approximately 32 different parts in order to have a shaft large enough and adequate enough to carry the pressure required so we replaced the bent shaft with others of the same dimension and now are proceeding gently to attempt the required electrical manifestation. It appears unless the shaft again gives out on us we will be ready for new testing by tomorrow. If successful, you will hear from me by phone. In order to put in the adequate shaft it requires 32 different machine parts, a cost of about \$2,000.00 and a delay of about 10 days.

I am approaching all the problems objectively and realistically and have come to a definite conclusion regarding a solution. What faces me at the moment would not be solved by the Canadian interest or the cooperation necessary to survive. However, I am confident when I am in the position to force the issue the Canadian Contract can be made lucrative and valid as we have agreed upon.

I feel somewhat like Columbus. When mutiny threatened and the chant of all the men was "turn back before it is too late", he had to arrive at a decision and make an agreement by date if land was not sighted the voyage would end. My predicament is no different from any of the adventurers who have stumbled upon technology not acceptable through either science or the masses. However, Columbus gained new inspiration with each full moon. He did not give up and he succeeded. Every minute that my machine runs and I see pressure put to work by weight rising up due to the floating fulcrum I have the same inspiration and neither will I give up. Incidentally, springs in their proper arrangement of expansion and contraction perform identically the same work as inertial weight and when we are able to do so we will probably surplant all inertial weight to the proper spring arrangement.

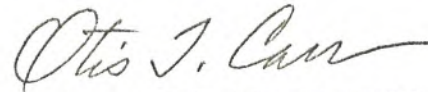
In order to bring my machine into being in its present state, to maintain the Research and Development Institute and in order to keep secure and move ahead progressively, I need an immediate minimem budget of \$60,000.00. I have set the date of August 10th to have these funds on hand or I will have to turn back in one sense, by closing the doors at this location. I am writing all of our suppliers, at least fifty in the Pittsburgh area who, if we do business in the future will gain much, asking them to come by and not to lower the boom on the present bills I owe them but see if they can find a way for me to survive. These nine days I have left I will explore every possible chance to raise money, such as bankers and individuals. If you have amongst your associates anyone who would like to own 1/5 or 20% of all we are getting ready to introduce to the world, providing action is immediate, for \$60,000.00. Anyone I talk

to or do business with from here-on-out I will be soliciting aid, so don't be offended by the proposal.

This about winds up my thinking regarding the policy and the program as I see it and I will devote time to making the sketches on the present machine to validate the technology released to you because we have put it into physical practice and because there are things you should know in writing the patent. Incidentally, my program includes time to make the \$2,000.00 change on the machine that is required if I am to have it perform as it should.

It is always a pleasure to meet with you and I enjoyed your courtesy and consideration on your last visit and I hope that we will always associate together.

Enclosed is a check in the amount of \$607.04 for the bill presented.

We have started today on the fabrication of the 50-inch fly wheel for "Big Joe" with the suspended centrifugal spheres. The steel frame fabrication will begin on Tuesday, September 1, 1964 and with luck and no unforeseen delay in equipment it should be ready around September 10th. As soon as it is completed with 100% efficiency I will want you to return to Pittsburgh to complete the patent and get it in the works.

In the meantime, if you have everything prepared on the dimensional magnet you might send it on to me for examination.

I am enclosing photographs of how the dimension bar magnet will be used in a gravity magneto type machine for power gain electrical energy transfer. Needless to say, these disclosures are highly confidential. I certainly feel that this magneto is a true 4th dimensional machine. The lines of force 180° apart are crossed dimensionally in the field rather than physically which was the only method heretofore. Such effect would have produced neutral effect. We have gone beyond the three dimensions and dynamically added another. The far reaching effect of this will be made known when we have ran our series of tests. The photographs are of our wooden mock-up design so that when we turn it to metal our dimensions will be accurate.

Dear Mr. Dunlap:

Due to circumstances beyond control, my program is running about six weeks behind the original schedule. Thanks very much for your letter of several weeks ago confirming that you had accepted the position of patent counsel for me in my present activities and acknowledgment of the money order I sent to you for travel expenses from Oklahoma City to Pittsburgh.

This unavoidable delay was caused by personal illness of two weeks, an unexpected death in the family - my youngest brother - and a breach of contract with my financial associates in Canada.

We have reformed our forces and are now ready to move forward again with, we hope this time, no undue interruption. Therefore, within a few days I will need your services here. You will be given ample notice of the same by telephone.

The specific work involved will be the filing of four basic patents and all of the procedures relating to them, plus a filing of caveats and/or proper announcements in many foreign countries. The four specific patents will all be in the energy transfer field, and one of them is well described in two pieces of confidential literature which are being mailed to you separately by insured mail. Watch for it.

This describes heavy industrial equipment and has many patentable features. However, in the same energy transfer field, we will file another patent on a machine that is about one-tenth the weight and cost of the descriptive literature which will do the same work.

I am looking forward with pleasure to meeting with you again. I have tremendous confidence in your integrity and your ability. You have much work to do for me, and I am certain it will be gratifying.

Somewhere in the dawn of history, free energy first expressed itself to man in the mystery of fire, wherein an action once begun kept multiplying its reactions and so man started to control the reaction to bring comfort to his position as an observer and his right to explore the future. Out of this type of reasoning came the laws of perogative instances and civilization as we know it now is the product of these laws.

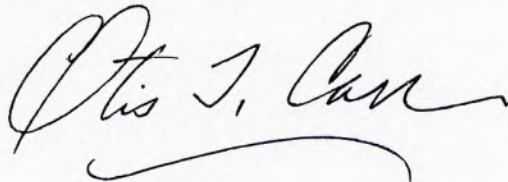
We symbolize the beautiful humming bird and use it as our trade symbol because, as a minute combustible engine of nature it shows the most promise of power-gain in energy transfer. By comparison, it has been evaluated that a grown man would have to consume 180 Lbs. of ground meat a day to produce the same amount of energy that a humming bird produces in its daily pursuit of food from the nectar of certain flowers. The humming bird is a vertebrate the same as we are and is therefore a combustible engine of nature built around the oxygen carbon cycle, etc.

We have properly named our machines gravity, electro-dynamic systems and it is well to explore the word systems to find out that it is a product of being. Gravity is a term which is a part of our language of understanding as relates to the inertial attraction between masses and the differential being provided free by universal law. Dynamics is self-explanatory and means electricity in motion or its manifestations. In order for any power to manifest itself in any form of power within its own homogeneous arrangement a transfer or a transmutation must be acted upon by an outside source and this is exactly what

we do in our machines. We alter the field of gravity and by so doing we change its power potential without in any manner disturbing the field's entity as such. Therefore, our machines operate without any dissemination of the molecular entities involved. We don't smash anything, we don't split anything, and we do not injure the atom in any way. 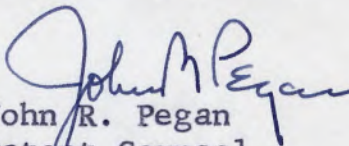

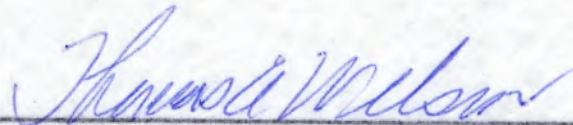

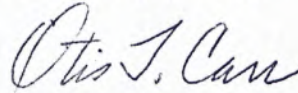

In response to your letter of December 2, 1966, six of our technical experts met with you and your staff to witness a demonstration and to discuss the Carr Gravity-Electrodynamic Systems in the Continental Room of the Statler-Hilton Hotel on January 5, 1967.

At the initiation of your presentation each of our representatives was furnished a copy of the following:

1. Proposal for Power-Gain Development - Contract with United States Department of Interior and Application of Such Systems as Low Cost Power Sources for Seawater Desalinization, Atmospheric Purification, etc.
2. Confidential Technical Report Disclosures, and Physical Demonstrations of Power-Gain Energy Transfer Systems for Information for the United States Department of the Interior by Otis T. Carr, Carr Gravity Electro-Dynamics Systems, Inc.

Each of these brochures were read aloud by you to the group. This was followed by a color movie demonstrating the operation of an earlier model, a blackboard sketch of the operating features, display of a wooden model of the mechanism, and a discussion in which our representatives participated.

As we understand your proposal, you are offering to the United States Department of the Interior an opportunity at this time to enter into a letter of definitive contract with you in the amount of \$500,000 for the development of prototype apparatus.

It is the unanimous opinion of our experts that the material presented during your demonstration is not sufficiently substantive from a technical viewpoint to reach any judgment as to the workability of the Carr Gravity Electrodynamic Systems. Thus, to proceed further, it would be necessary to accept on faith your concept of a mechanism which employs latent gravitic energy to secure a power gain between the input and output of a given mechanism or which, as you stated, constitutes a Perpetual Energy-Motion Machine. We would similarly have to accept your thesis that this machine is incorrectly considered as being in conflict with generally accepted physical principles and that a new set of physical laws must be established in order to describe adequately the energy sources of Power-Gain apparatus.

We cannot visualize your new principles in the light of our knowledge of the fundamental laws of the conservation of energy or motion. The description and analysis furnished is not in sufficient detail to enable us to gain an insight into the fundamental scientific principles underlying the design and operation or the economic feasibility of your Power-Gain Energy Transfer Systems. Further theoretical clarification would be necessary before we could arrange to have tests performed in a Government laboratory on any working model you might provide to demonstrate the workability of the Power-Gain equipment. We realize that you would not want to make a disclosure until after adequate steps have been taken by you for patent protection.

Although we appreciate your offer to make this device, together with your knowledge of its features and operation available to our Government, we do not want to discourage you from proceeding with such private plans for development as you may see fit.

Carr Gravity Electro-dynamic Systems, Inc., founded by Otis T. Carr, inventor and developer of the science of Power-Gain Energy Transfer which permits the construction of Power-Gain mechanisms, proposes to the United States Department of the Interior the entry at this time into a letter or definitive contract in the amount of \$500,000 for the development of prototype apparatus.

The concept of a mechanism which employs latent gravitic energy to secure a power gain between the input and output of a given mechanism in effect constitutes a Perpetual Energy-Motion Machine, i.e., one which continuously produces more energy than it consumes, the difference being available as a prime mover for electrical power generation, and is accordingly considered--incorrectly--as being in conflict with generally accepted physical principles. Actually a new set of physical laws must be established in order to describe adequately the energy sources of Power-Gain apparatus. Needless to say, the availability of substantially Free Power has unlimited applications to every field of technology, particularly such areas of high power consumption as seawater desalinization and atmospheric purification.

The Patent Office has acted on the Company's preliminary application and has requested a validated report of performance. The basic specifications of the machine which we propose to demonstrate to the Patent Office and on which we expect to have a validated report in their hands prior to February 10, 1967, are as follows: One horsepower input; wattage range 700 to 1,000 watts; 5,000 watt generator output continuously. When the machine is activated by an outside source and the generator is at full 5,000 watt capacity, within a matter of seconds the necessary wattage, approximately 800 watts, is fed

back from the generator to the input motor to eliminate the necessity for further input power and leaving a remaining output of 4,000 watts for any use required. The demonstration of this machine will be continued for any length of time from one hour to days without load variation, if required, and will include the operation of light bulbs and other electrical appliances consuming the 4,000 watt output.

To demonstrate Power-Gain apparatus at the present time we have brought to Washington for this meeting a model of the mechanism involved, a motion picture of the operating prototype built in November 1963, together with engineering reports confirming the existence of a power gain in the mechanism.

In view of the extraordinary industrial applications of the Power-Gain type apparatus, we desire to avoid any premature publicity and ask that the present discussion be considered confidential.

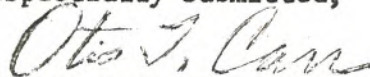
We currently propose to supply the Department of the Interior with a prototype Power-Gain apparatus on which any necessary studies of power gain energy transfer may be made for the purposes of evaluating their feasibility in projects requiring low cost power sources. Construction and testing of this research prototype, together with access given to the Department to the technology developed by Mr. Carr in this field, is put at half a million dollars. It is, of course, clear that if actual power gain can be demonstrated to the extent previously described as the design specification of the prototype to be shown to the Patent Office, further construction and development funds required would be in considerably greater amounts.

The demonstration is made at this time to the Department of the Interior at the insistence of Mr. Carr that the matter should be first

offered to the Government before being turned over for commercial development under existing offers. - The National Rural Electric Cooperative Association (NRECA) in a preliminary meeting recently agreed tentatively that on completion of our present patent procedure, they will finance the construction of a plant for time study data and display our operational prototype to their membership at the national convention in San Francisco beginning February 19, 1967. - The Company presently has a \$2,000,000 escrow agreement from private sources which will become immediately available to the Company for an interest in the corporation upon performance of the patent demonstration as previously described. - Canadian manufacturing rights are the subject of a million dollar and royalty offer which has been made to us by private interests in Canada.

Under the circumstances it would appear that Government participation in the further development of Power-Gain Energy Transfer apparatus would, at the present time, offer a substantial savings to the Government over future commercial procurement. The amount presently requested is negligible in terms of the ultimate benefit to be achieved. It should be kept in mind that whatever doubts may exist as to theoretical considerations which, on the basis of present knowledge, would deny the possibility of utilizing the forces of gravity to increase the amount of power which can be transferred through a mechanism, the unbelievable potential of low cost or free power is of such importance that every rational possibility for achieving such a result should be made the subject of thorough research and evaluation.

This meeting was called to order on January 5, 1967 in the Continental Room of the Statler-Hilton Hotel in Washington, D.C., to present in its entirety all of the factual evidence required to prove Power-Gain Energy Transfer. This technical data report is accompanied by a proposal to the United States Department of the Interior which has just been read to you assembled here.

To begin this series of demonstrations and explanations I will start with a brief preface of myself and some historical background of the paths of research required to have this breakthrough and inasmuch as this is all of historical record as of this date, there is some importance attached to the following:

I began my researches in energy at the age of 18 in Cleveland, Ohio in the year 1922. Since my childhood I was always gifted with one attribute that has never failed me and that is that from the beginning I always went to the highest source of information as quickly as possible. In any development of this century we all build on the shoulders of giants who with little tools to work with in the two preceding centuries, came up with phenomenal discoveries that we were fortunate enough to inherit.

I had the good fortune to meet and talk with Dr. Steinmetz of General Electric in 1922, and was tremendously inspired by the fact that the electrical age bursting upon us had infinite possibilities. Shortly afterwards I sought advice from one of the forgotten pioneers, Mr. Hudson Maxim and his unique knowledge of the control of gases and sound was truly inspirational. I then moved to New York City to carry on my studies and located Mr. Nichola Tesla and had the rare good fortune of being in com-

munication with this great mind for three years. The studies continued and the assistance received from such men as Vladimir Mitkewich and Mr. Faber Birren made it possible for me to get a wide diversification of knowledge in physics and the natural laws of motion in the universe so that my researches and experimentation were made with confidence.

When I had reached a certain plateau I contacted Dr. Albert Einstein in the year 1939 and I can truly state that this great man has been the true guidance factor in the success that has now been accomplished. I am further indebted to Mr. Palmer Putman who in 1951 wrote the best book of its kind published to that date, entitled, "Energy in the Future." This precise, authoritative work dealt with tremendous accuracy on the problems now being faced day by day in the energy needs of this nation and the planet as a whole. The last great work to complete all of the authoritative information necessary to build a universal power gain machine was forthcoming in the excellent work of Mr. Crawford Greenwalt, Board Chairman of DuPont who made the most comprehensive investigation of hummingbirds and published it in book form along with furnishing all the material to the National Geographic Society.

By 1942 I had proven to myself that gravity has polarity just the same as the magnet and is therefore both positive and negative with a surrounding field. I was able to construct a small hand model that ran itself by the release of stored up energy in a spring under a time lapse sequence. This of course, was a great novelty which I kept completely classified. Though it ran and would run for years without interruption, it produced practically no additional energy but I did know that if I

followed the true knowledge of the polarity of gravity I would get what I was seeking - Power-Gain Energy Transfer.

We will now start with the disclosure of the Power-Gain Energy Transfer here with the understanding that my request for it to be confidential relates to no publication of the material wherein it could get into other hands prematurely. My rights as relates to patent procedures are protected and any disclosures made here are strictly for the understanding of the audience.

When I had accomplished real success by the year 1952 in Power-Gain Energy Transfer I contacted the United States Government with the hope of getting some funds to carry on the work without interruption or delay. My contact was with the National Inventors' Council and the government individual was a Mr. James Kanegis. I found him to be a courteous, understanding individual who never once voiced ridicule at my effort or stated that it could not be done. After two or three conferences with him I decided to make a demonstration with the view to getting government assistance which Mr. Kanegis assured me would be forthcoming immediately. In my discussion with him he pointed out to me one direction in the field of gravity dynamics which I had more or less overlooked. This was the law of the pendulum and variations of the same. I shall always feel kindly towards this fine gentleman for this last discussion we had in 1952.

I re-examined the material I had planned to reveal to the government and I could not see how it would have much value except as a novelty in the very low wattage output field and I withdrew from any further effort for government assistance or disclosures at that time.

The thousands of dynamic tests that I have made since proved that this was wise and now we are able in a conclusive manner to introduce Free Energy to the planet Earth for the welfare of all.

We are now going to show a movie projection of the first machine on a full scale size that automatically ran itself. We have a witnessed validation report plus a validation report that this same machine produced more than 100% efficiency in continuous operation. faction and relief that I am now able to share this knowledge and know that from henceforth on, it will be expanded and grow on the planet Earth.

The basic key #1 is input drive totally divorced from output drive. Which means that using gravity in its attributable form of centrifical force we can calculate in advance the amount of excess energy required for any given machine and activate this energy at its full capacity without any variation of the input load. I will now demonstrate this to you on the machine sitting in front of us.

Basic key mechanism #2 in any reciprocating mechanism wherein an arc is created, compensation for this arc due to distances traveled, must function automatically without any loss of pressure. The simple demonstration given to you now is all inclusive and speaks for itself.

With these two basic keys now defined to you the age of Free Energy is born. Due to the tremendous significance that this technology will have on all people now alive on this planet and those to be born, you can understand why in true humility I ask my government to lend a hand in seeing that this powerful force is used for good rather than destruction.

Everything that is needed by me at this time is enclosed in the accompanying proposal. I am not interested in procedures or protocol as such. If my government cares to act in my behalf we will be available and we will stay here in Washington because it is the end of the week, until the first two days of next week - Monday and Tuesday. I will expect an answer by that time.

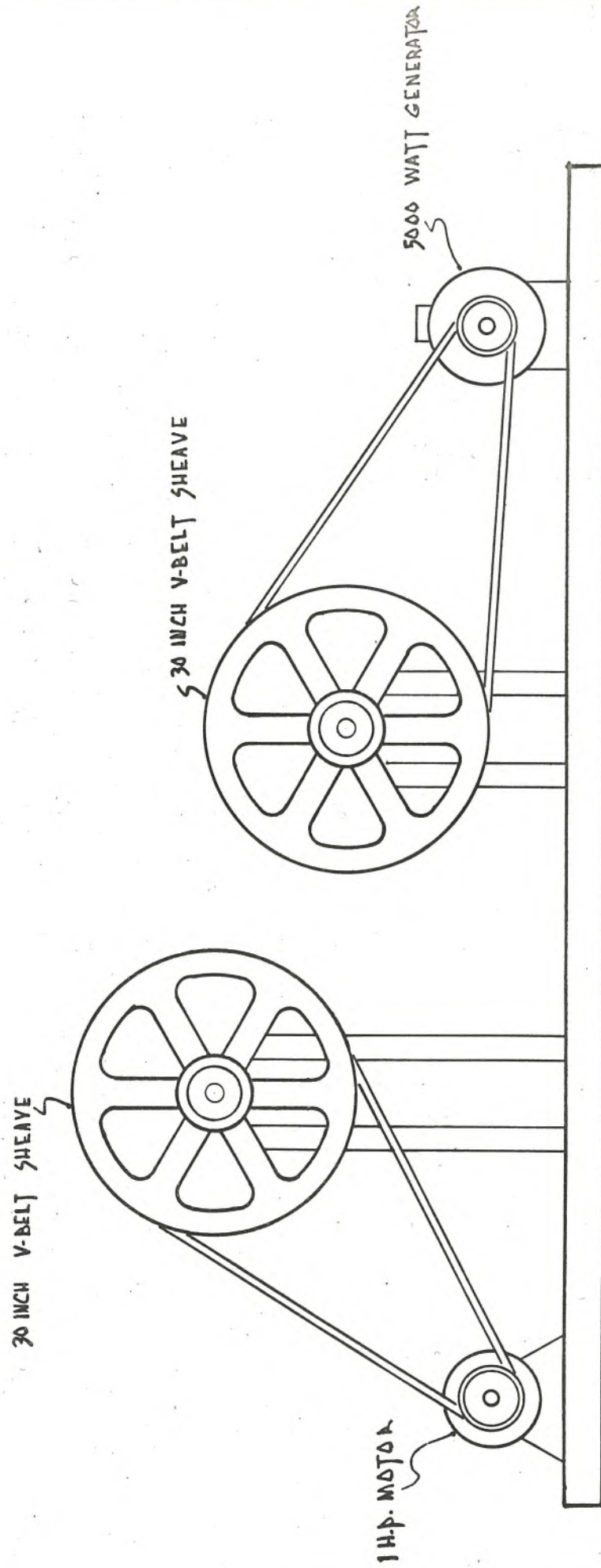

BASIC KEY MECHANISM TO POWER GAIN DEVICE



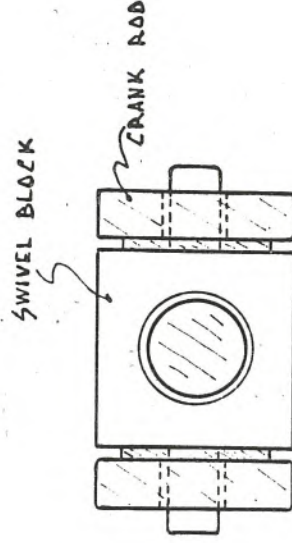
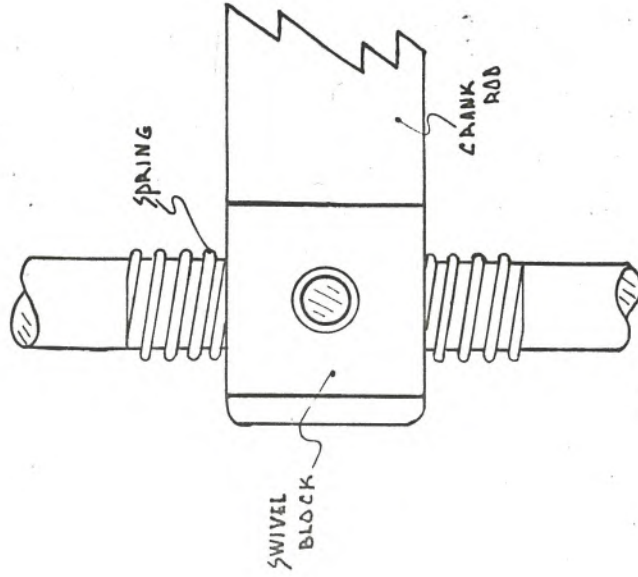

Dear Mr. Carr:

In reference to my letter to you dated October 16, 1967, I have received a reply by letter dated October 24, 1967 from your attorney George S. Leonard of Washington D.C., a copy of which he transmitted to you. Please be informed that I reject the recommendation proposed by Mr. Leonard.

You will find enclosed herein a copy of a letter dated November 16, 1967 I have received from Mr. Levi M. Smith, Registered Professional Electrical Engineer, experienced in Government and Private power projects in the United States and abroad. This letter is a report of analysis by Engineer Smith furnishing additional evidence that the Homestead Machine report dated January 15, 1964, test data page 9 of the Technical Report you submitted to the Department of Interior Washington D.C. on January 5, 1967 is an incomplete, inadequate, inconclusive and invalid report of power gain on the Homestead Machine report dated January 15, 1964. This is acquiescence to the finding of no power gain by Electrical Testing Laboratories Inc., New York, N.Y., *AND BY ELECTRICAL ENGINEER MILTON PALKOWITZ IN HIS LETTER TO YOU DATED OCTOBER 19, 1967.*

^A Where there is no power gain there cannot be a recycling. Therefore, the Homestead Machine recycling and test reports pages 7, 8, and 9 of the Technical Report you submitted to the Department of Interior are not valid reports and must not be used in the promotion of your power gain technology. To continue the representation of these invalidated and misleading reports, when you never had and do not now have a power gain machine, has the appearance of subterfuge, shysterism and fraudulent representation to secure financial support.

When written request was made by the United States Patent Office that you furnish proof of purported power gain you claimed in your Patent Application, you failed to furnish proof and abandoned your Patent Application, which is further proof that you never had over 100 percent power gain in any of your machines.

All of the people who have advanced funds to you, over two hundred and twentyfive thousand dollars since 1962, in support of you and your wife, and your technology, did so on the basis of the

fact that you claimed you had previously completed all the experimenting and testing and that you had previously built small models producing over 100 percent power out, ^{PM} and that all that was now needed was funds to build a larger power gain model, and no more experimenting. To date none of your larger models produced over 100 percent power output, which is proof that your smaller models did not produce over 100 percent power output. Your financial supporters were mislead. In addition since 1962 you have over sixty thousand dollars of unpaid trade creditors and wages. Prior to 1962 there were substantial cash advances to you and your corporation, O.T.C. Enterprises Inc., and unpaid debts in Baltimore, Md., Oklahoma City, Oklahoma, and Apple Valley, California.

In view of the foregoing and with respect to my letters to you under dates of September 12, 1967 and October 16, 1967, unless I receive information from you by mail on or before December 16, 1967 that the invalid McKeesport Machine report dated in the fall of 1964, and that the invalid Homestead machine report which you submitted in the Technical Report to the Department of Interior Washington D.C., as pages 7, 8, and 9 bearing dates November 23, 1963, January 4, 1964 and January 15, 1964 respectively, that such reports, the original and/or copies thereof, are not being represented in the promotion of your power gain technology by you, the corporation, or under any other name, I will report the matter to the Department of Interior, the National Rural Electric Cooperative Association, the S.E.C., the F.B.I. and to the Pittsburgh Office of the Attorney General of the Commonwealth of Pennsylvania. A copy of this letter is being sent to your attorney George S. Leonard, 1725 K Street N.W., Washington D.C.

Dear Mr. Carr:

I have reviewed the injunction issued against you in June 1959, and note that it prohibits you or any persons associated with you from using any interstate facilities in the sale of any securities absent an effective registration statement, subject to the exception that the provision shall not apply

"to any security or transaction which is exempt from the provisions of Section 5 of the Securities Act of 1933, as amended."

There are two exemptions from the applicability of Section 5, which may be of importance to you in reimbursing the advances of your backers by the issuance to them of investment stock. First, an exemption exists under Section 4 (1) covering transactions "not involving any public offering". What constitutes a public offering is a matter of interpretation and there is no fixed number of offers which can be made. It is true that as a rule of thumb which is not binding upon it, the Securities and Exchange Commission has customarily taken the position that an offering to not more than 25 or 30 persons is generally "private". However, you must keep in mind that the purpose of this exemption is fundamentally to allow distribution of stock among persons who are not members of the public as respects the issuer. In other words, they are persons who have full knowledge of the speculative nature of your operation, of its intention to develop a technology which in common scientific belief is impossible, and are persons who would receive such stock against advances made to you, as an individual, during the development period of your apparatus. Combined with these factors together with the intent of these people to take the stock for investment and not for resale, we would be of the opinion that a distribution limited to not more than 25 such persons would violate neither Section 5 of the Securities Act of 1933, as amended, nor the injunction of the United States District Court for the Western District of Oklahoma in Civil Action file #8452, filed on June 5, 1959.

I have reviewed the form of receipt provided to you at our last meeting and I am of the further opinion that it constitutes an adequate ratification by the proposed stockholder of his intentions and knowledge of these matters.

The second exemption available to you is the so called "intrastate" exemption. Section 3 (a) (11) of the 1933 Act exempts a security from the applicability of Section 5 when it is part of an issue which is offered and sold only to bona fide residents of a single state, and where the issuer is incorporated and doing business solely within that state. It is important to realize that this exemption is seldom achieved. Every person taking stock without any exception must be a person whose residence is and has been for some reasonable time in Pennsylvania. He must take the stock for investment, as in the case of the prior exemption referred to above. If these requirements are meticulously observed, and your distribution concluded without any certificate having been transferred by an initial purchaser and is not, in fact, held by an initial purchaser resident outside of the state, the cited exemption should be applicable.

Again, however, I caution you as I did at our last meeting that the Securities Acts alone are not concerned. The nature of your work is such that any failure on your part to disclose completely the speculative character of the investment and any of the facts which might, at some later date, be deemed sufficient to have influenced his judgment in investing, must be the subject of full disclosure. It is essential that you have in mind at all times that the various securities laws and other laws are not intended to discourage or prohibit investments no matter how tenuous the possibility of return. They do exist, however, with both civil and criminal penalties against any security transaction in which all of the potential loss factors, interests of the promoters, and other facts which could influence their judgment have not been disclosed.

At the same time, you should not prepare any written or printed circular, prospectus, offering sheet, or other document to be given out. It is substantially impossible to put down on any sheet of paper a sufficiency of facts to cover all possibilities of complaint by an investor at a later date. Such a paper would later be read as an unqualified and unapproved prospectus and might well be the basis of taking away from you the exemptions now available.

As I have told you, we are not admitted to practice in Pennsylvania. Although I have read your exemption certificate, the applicable statute and regulations of the state, I can do nothing more than say I find nothing in them to the contrary of the interpretation which you gave me. I would

say that they make clear that you have an absolute maximum of 25 persons in any event and that if any issuance of shares is to be made to a person who has not previously advanced money to you, it would be my suggestion that you seek the advice of Mr. Robb or other Pennsylvania counsel before doing so.

Summing up the manner in which your transaction should be handled in order, in our opinion, to minimize the possibilities of questions arising under the various laws referred to, the following should be observed in every transaction.

1. All arrangements for and delivery of shares should be by word of mouth and hand delivery. No offer should be made or discussion thereof had by telephone, nor should the mails be used for any purpose in this connection.
2. Each person to whom such shares are issued should be an individual who has previously advanced funds to you in your individual capacity for the development of your technology, and the shares should be principally in reimbursement therefor.
3. Each purchaser must be a bona fide resident of the State of Pennsylvania and should write his permanent address on the receipt which I prepared for you.
4. Each purchaser should not only sign the receipt, but acknowledge verbally that he does not intend to resell the shares and is taking them for their investment value.
5. Each purchaser should read the receipt and understand it, and have any questions he may ask answered in detail.
6. Counting yourself and Mr. Donatelli, there should not be more than a total of 25 offers made before the end of your distribution. Keep in mind that it is the "offer" and not the sale that we are concerned with.

I have added the mail and telephone restrictions above simply as an added precaution. They are desirable, but not essential. However, the offenses under the Federal Security Acts are normally couched in terms of an improper use of these means of interstate communication. If you later find yourself in a position that one of your stockholders has violated his investment agreement and resold his stock, particularly if resold outside of the state, you would need as favorable initial circumstances as possible.

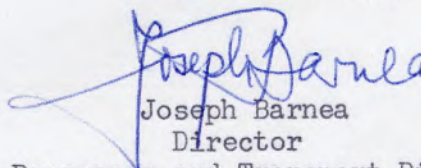

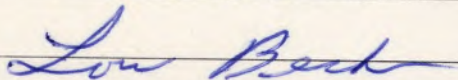

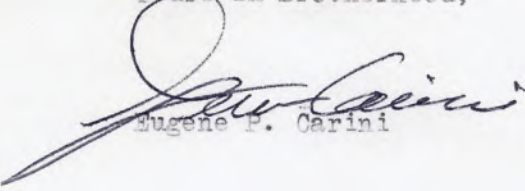

Dear Mr. Dunlap:

Our evaluation of Mr. Carr's Power-gain Energy Transfer Machine reveals that it cannot work for a very fundamental reason, which is that no machine may exert more force or torque than its base or support structure can withstand.

In effect, what Mr. Carr has is a Scotch yoke crank driving the final output with an intermediate mechanism in the crank as shown in Figure 1. The intermediate mechanism in this case being another identical Scotch yoke. Thus the crank or push-rod of the first Scotch yoke is the support structure for the second yoke mechanism. A simple free body diagram of the second Scotch yoke makes it quite obvious that it is impossible for it to exert more force than the support structure (the first crank) can withstand. When the force from the second crank started to exceed the force from the first crank, the first yoke mechanism will stall (or even reverse). Even if several mechanisms were connected in a similar manner the final one would still not be able to exert more force than the first.

The error in reasoning given on drawing #2 stems from a lack of understanding of "series" vs. "parallel" connection of mechanical elements. Power is merely work per unit of time, so consider as a simple example two identical machines that develop "Y" horsepower by exerting force "f" over a stroke "X" per unit time. (The crank or push-rod of a Scotch yoke is itself a linear motion device and transmits only force and not torque.) Now these two machines can be connected to give a power output equal to twice their individual outputs in two ways: first they may be connected in "parallel" to give twice the force (f) over the same stroke (X), or second they may be connected in "series" to give the same force over twice the stroke. The "series" connection is essentially what Mr. Carr has used, but it cannot give twice the force over twice the stroke to quadruple the output as stated on drawing #2.

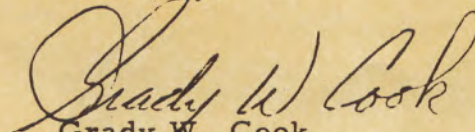

I am still working in the hospital. As you'll read from the enclosed letter, I have been trying to find Dennis. I do hope that someone does so he can hear the good news. I wanted to add also that the dear little red donkey you bought Kim has been saved all these years. I put it away and never looked at it, because after Dennis and Norman and you left me, not even writing or telling me where you were, I was so broken hearted and left with such large debts, that I became so nervous I almost had a nervous break-down and lost job after job. I still had about \$5000.00 worth of debts to pay back after all the money I had invested and used with which to help Dennis and Norman and had to keep finding new jobs and paying back money until it's a wonder I made it. My family couldn't accept any of this and our only out was for me to get a divorce, which I did.

Dear Mr. Fox:

About three weeks ago I received a telephone call from Mr. Carl Anderson, informing me of your letter to him. He informed me of the fact that you are now in the position to sell Gravity Units, and also that you are asking for information concerning Norman Colton and other people who are interested in Mr. Otis T. Carr and the OTC XI Project, which was located, at one time, in Hesperia, California.

After all these years, I was not only overjoyed, but so pleased that after the fact really was impressed in my mind through prayer the following morning, I broke down in tears and wept uncontrollably, out of sheer relief, joy, gratitude and humility, that all the efforts that Dennis, Norman, Otis and I have put forth, along with other investors, have not been in vain.

You do not seem to be aware of the fact that Mr. Dennis Rapoliti and I were western representatives for the OTC XI Project, which at first was called the "OTC Research Foundation", when I first became interested in it, and started investing my money. Later the name was changed to the "Millennium Agency.

I met Dennis in 1961, I believe, and also met Mr. Otis Carr and his wife then when they were living in the dessert. I spent many many days with Dennis, helping him secure investors for the Millennium Agency, and most of the time our efforts were successful. A list of the people we contacted is enclosed on a separate page, and a copy of this letter is being sent to each of them. On yet another page, I shall list the names of the investors and the amount they invested, to the best of my knowledge. I have gone to considerable length in the past to help Dennis with the project, and have continued to help him whenever I could, and also to help Norman Colton when he and his friends from Baltimore were out here and were guests in my home. Unfortunately I lost track of them. Dennis visited me in the spring of 1969, and at that time he was living in Los Angeles. He did not leave his address. 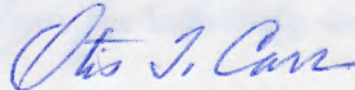
